

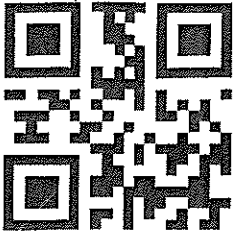

**KNOW ALL PERSONS BY THESE PRESENTS:**

The incorporators, all of legal age and majority of whom are residents of the Philippines, have this day voluntarily agreed to form a non-stock, non-profit and non-political professional civic organization under the laws of the Republic of the Philippines. *(As amended on August 31, 2013)*

**AND WE HEREBY CERTIFY:**

**FIRST:** That the name of the said association shall be:

PHILIPPINE ASSOCIATION FOR GOVERNMENT  
BUDGET ADMINISTRATION (PAGBA) INC.

**SECOND:** That the purpose or purposes for which such corporation is incorporated are:

1. To promote and maintain high professional standards and ethical conduct among personnel involved in budget administration;
2. To encourage and promote programs for budget and fiscal management improvement in the government service, help secure scholarships and conduct seminars and in-service training conferences for its members and other government employees concerned in government budget administration and fiscal operation;
3. To promote better understanding, fellowship and cooperation among members of the Association;
4. To promote, maintain and safeguard the common interests and welfare of its members;

5. To help conserve faith of the people in our daily constituted government and to help accomplish the realizable results and goals of established budgets;
6. In general, to actively contribute and participate in ensuring the preservation of the high degree of integrity and standard of our participation in the administration of the budgets of agencies of the government of the Republic of the Philippines;
7. To purchase, lease, own, hold, acquire or otherwise accept such property, real or personal, as maybe necessary, convenient or appropriate to serve the purposes herein expressed; and

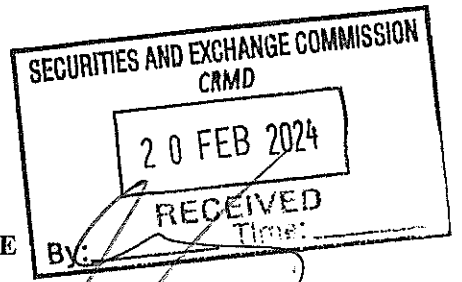

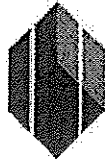
